BROOKLINE SCHOOL DISTRICT 2021 ANNUAL MEETING

This year the Brookline School District's Annual Meeting will be conducted in accordance with the requirements of House Bill 1129. These are the procedures that will be used:

Between February 1, 2021 and February 8, 2021 at 6:30 pm, registered voters may submit comments, concerns, and requested amendments to the School Board electronically at the following email address kenneth.haag@sau41.org. Additionally, registered voters may submit written comments, concerns, and requested amendments at the Superintendent's Office located at 4 Lund Lane, Hollis, NH, 03049. All submissions must include the name and address of the voter and shall be verified against the check list for eligibility and will be read at the online virtual Annual Meeting scheduled for February 8, 2021. Comments both in support and against the warrant articles are encouraged. No live comments or questions from registered voters will be allowed at either the February 1, 2021, online virtual Information Session or the February 8, 2021, online virtual Annual Meeting.

On February 8, 2021, at 6:30 pm, the School Board will hold an online virtual Annual Meeting to read all submissions received from registered voters, to review the procedures for voting, and to discuss, debate, and potentially amend the School District Warrant. Once all timely submissions have been read, the School District Moderator will introduce each Article on the Warrant and the School Board members will move the Articles one-by-one to the Alternative Ballot either as posted or as amended by the School Board. On Tuesday, March 9 2021, between the hours of 7 am and 7:30 pm voting will be conducted in person at the Captain Samuel Douglass Academy located at 24 Townsend Hill Rd, Brookline. The ballot will require voters to approve the process used to conduct the Annual Meeting. If the process is not approved, the warrant articles on the Alternative Ballot shall be deemed disapproved and the School Board may either hold another meeting prior to September 1, 2021, to adopt an operating budget or the School Board may deem that the meeting adopted the prior year's operating budget, not including separate warrant articles. Voters should mark the entire ballot even if they do not approve of the process. All election results will count regardless of whether the optional process is approved. The results of the voting shall be posted on the School District's Website at www.sau41.org and will be reported to the local newspapers.
